# The Power of Literature

I have noticed that a lot of meetings are focused on book studies these days. I think I heard someone at our last Assembly say that book study meetings appeared to attract younger audiences, also. So I made it my business to attend a few of these meetings, and I just happened to join a group in progress that utilized "Many Voices, One Journey". I wanted to take a moment and share an insight I received from this particular piece of CAL.

I've been in Al-Anon for years and didn't think a compilation book would really speak to me, so I didn't purchase "Many Voices, One Journey" when it was published. I have loved "Opening Our Hearts, Transforming Our Losses" and "Discovering Choices", which are topical books by nature. When I am dealing with grief or making decisions, I know I can turn to those pieces of literature for collective wisdom. But what use did I have for voices from the past?

As I sat around a table and listened to each group member read a portion, I was surprised at the content. I was hearing very old words that seemed strikingly valid for the current age. When it became my turn to read, I found myself reciting the words of our co-founder, Lois. She was talking about rotation of leadership and how the same people were perpetuating service, even then. She talked specifically about GRs and stepping down so someone else in the group might feel a call to service, and step up.

As I read her words and formulated my own based on the reading, I realized I needed to give my group notice as their GR. I am no stranger to service and I have completed 2 terms as GR for the same group. When no one volunteered to take over the role in January, I agreed to continue on until someone else showed interest. Guess what? No one has shown interest, despite my various efforts to rally the troops. Lois' words confronted my enabling behavior, though, and I told my group at our next business meeting that I was giving my notice.

Nothing has changed with my group since then and no one has approached me wanting information on



becoming a Group Representative. Does this mean I made the wrong decision? Nope. Does this mean my group is going to suffer and be without representation at Assemblies? Maybe. Does this mean that I am responsible for cutting off the flow of information and crippling the Links of Service? Yes, I believe it does. But I did it for my health and the health of my group, and to honor the Principles of the program.

Sometimes, I think chopping off an appendage to save the rest of the body is the right thing to do [insert graphic here...oops, can't use that graphic...too graphic ©]. I don't want to see my home group left out or left behind, but I also know I have limits and that I alone am not Al-Anon. WE are Al-Anon. So I'm going to trust my Higher Power to raise up a new GR, and I'm going to be confident in my decision to step back. In other words, it's just another opportunity to work my program –maybe a little bit deeper this time. Sincerely,
