Audit Budget Report – Linda S., <<u>Report in attachments</u> Wanted to point out some things. Delegate funds are higher and these costs are out of our control. The WSO ETF is a figure the World Service Office gives to all the areas. Costs are higher because of the location. Will need to have a Legal review for the Alateen Safety Requirements and are allotting the \$1,000 for that. Also, updating Background checks is estimated at ten AMIAS background checks.
