- Questions, Comments, Concerns?
 - A few years ago there was a Public Outreach Project for placing Signs on buses. At our newcomers meeting we ask newcomers if they saw the signs and they say no. They come by other means but not the signs. Is this the best way to share the program? This group passes out Al-Anon Faces Alcoholism (AFA's) that have a sticker on them stating the time, Date & meeting location information.
 - Al-Anon is different, this is not a membership drive, and this is a way to plant a seed. Our brand is brand awareness, one of the goals to reach public awareness.
 - Anything getting out is better than nothing getting out. Television and Radio skew a lot more of the older area. We are missing a gigantic piece which is digital marketing.
 - This is Oregon Money We need to get the most bang for the buck How does it effectively attract membership when the flyers could be being picked up by visitors.
 - Having it printed on heavier paper is necessary but a home printer will most likely be a Jet printer which is susceptible to the ink running.
 - Lots of money but we can't afford lots of TV.
 - Need to split CPC & Public Information on the budget Line items, currently both under Public Outreach Action Committee Budget.
 - CPC currently has plans to spend some of the money in this year's budget. So if this project was going to take all of it then maybe the project scope will have to be narrowed.
 - Is having the WSO contact on the displayed literature the way we would want to go or would we want it to be Oregon Area? The Book mark is available so we can add local information.
 - This is thinking outside the box. I would pick them up for family and Friends.
 - The Public information coordinator is the trusted servant and doesn't require approval from the assembly to go forward with a project with in a budget.
 - How does the literature get to the location? It would ship directly to them.
 - Can we do less than 12 months? Yes we can
 - It doesn't matter who picks up the literature, Al-Anon's primary purpose is to help family & Friends of Alcoholics whether they are in Oregon or not. It may not be the person who picks it up that ultimately is the person who walks through the door. They may just be the messenger. They may drop it and the person who picks it up will be the person in need.
 - We can't lose with this project.

Book Report How Al-Anon Works for Families & Friends of Alcoholics; Emily C. GR Dist 6

How Al-Anon Works is a complete anthology of the Al-Anon program. It's a compilation of information including our steps, traditions, slogans and stories of success. Many groups gift this book to newcomers because it is such a rich introduction to the program. Part one contains information on the Al-Anon program, and the second part is stories of personal experiences.

How Al-Anon Works introduces the reader to a wide variety of Al-Anon members. Readers meet the single woman who continued attending Al-Anon after being honest with herself about her relationship with an alcoholic. The book introduces a War Veteran who hit rock bottom and found Al-Anon through the advice of a counselor. One story walks through a husband's experience with the Al-Anon slogans as they relate to an ancient prescription for sanity. Whatever the reader's personal experience, they are likely to find a story with which they connect.

- The first group I attended regularly, was simply a study of this book. We would read paragraph by paragraph, pausing to discuss as desired. There was often a creepy irony that people were sitting in just the right spot to read aloud what they needed to hear. It was as if the book knew what pearl of wisdom was perfect for each person that day. At home, I would read ahead, and at first, I was surprised when the same passage held new importance when read in the group. But, as I continued the book, I realized how much meaning is contained between the covers. It is a book that can be read and studied over and over without losing its impact. How Al-Anon Works is a meeting in book form, and I highly recommend picking it up, asking your higher power to help you flip to the right story for that moment, and seeing what you find.

Audit/Budget Report: Sue B. Audit Budget Chair

The audit-budget committee met and audited the first quarter books for the Oregon Area. We found the amounts reported to agree with the amount showing on the March 2019 Bank Statement. There were a few adjustments to amounts paid to individuals who will be notified of these amounts. Invitation to Participate in the Oregon State Young People in AA Convention (OSYPAA): Dawn K. Chair

- Dawn K. Chair invited Garrison (by Phone) a representative of the OSYPAA committee to call in for an
 explanation, question, answer and formal invitation for Oregon Area Al-Anon to participate in the Oregon State
 Young People in AA Convention in Medford Oregon this year on November 8-10, 2019 @ the Inn at the
 Commons.
- What is in the plans There will be big speaker meetings, panels, hopefully 2-4 Al-Anon panels. There will be
 Marathon meetings for AA around the clock, with Al-Anon participation there will be some Al-Anon meetings
 throughout the day. There will be multiple events at the same time.
- They hope to bridge the gap between the two fellowships.
- Definition of a Young person in AA is anyone with room to grow or is young at heart. There is a certain energy about the YPAA events that have even those that are well experienced (Seasoned Veterans those that became sober at a young age and AA helped them find help and gave them a life worth living.)
- The Theme of this year's OSYPAA is: Limitless Expansion (What does it mean?) Expansion to grow without limits. On the back of their program sheets & lanyards individuals can write what limitless expansion means to them. We all have our own definitions. By following the principles of the AA program Limitless expansion is possible.
- Questions:
 - Could we also extend the invitations to the Alateens? Absolutely
 - o Is this backed by Alcoholics Anonymous in Oregon? Yes by the Oregon Area General Service Board.
 - What would the Al-Anon responsibility be? Show up, have a good time, organize the Al-Anon panels of speakers, Al-Anon meetings, and planning any workshops Al-Anon wanted.
 - Money What happens with the money raised? Goes to cover the cost of the event, the Advisory committee, the General Service Structure & the Next hosting committee as seed money. Each individual pays their own way.
 - What about the money raised by Al-Anon's? (7th Tradition & such?) Garrison will take back to his committee to find out.
 - Is OSYPAA a Service Arm YPAA is a group of a Service arm of AA and are part of the AA autonomy. Their primary purpose is to help sober another Alcoholic. The bigger conference ICYPAA (International Conference for Young People in AA) is a Service Arm of AA. Garrison will have to check if OSYPAA is registered as a Service Arm.
- Vote: How many Group Representatives would support cooperation with OSYPAA to put this conference on?
 This means you support Oregon Al-Anon cooperating with OSYPAA, it does not mean you will attend or be a direct part of.
 - Simple Majority Yes, (~27), Abstaining (~3), No no's
 - Minority Opinion (~3) Would like to make sure that this organization is affiliated w/AA
- Dawn explained to Garrison that Oregon Al-Anon agrees to participate, contingent on the Affiliation of OSYPAA with AA.
- Reggie DR 7, is acting liaison.

Coordinators – Reviewed what they were working on in their position, what kinds of projects they could work on using the members of the Assembly, Discussed what workshops they see the Assembly having in November.

 - Two Alateens shared their personal experience with Alateen & Oregon Alateen Conference (OAC). Both joined the OAC committee.
 - They invited everyone to support the teens and asked for donations to assist with scholarships for Alateens to be able to attend OAC in August.
 - Alateen Sponsorship
 - Passed out Alateen Sponsorship "Is it for you" questionnaire S-27
 - Had Oregon Area Alateen Sponsorship Candidate Application for anyone that is interested.
 - On-Line meetings have two Sponsors
 - If the commitment of 3 years is holding members back from being an Alateen Sponsor then would people be interested in paying their own \$45 for the background check? Currently the District pays it but if members paid their own fees then a 6 month term of service could be a reality. Keeping in mind that the teens need consistency.
 - Alateen Chat lines There are AMAIS on the Chat lines that read each post before it is posted.
 - Northern California has a weekend long Sponsorship Retreat.

Questions

- What keeps teens coming back to Alateen?
 - A parent's encouragement to go. This allows time to make a connection. For one it was the escape from the house and the meeting felt safe and welcoming. There are going to be teens that won't come back. As more people came to the meeting they fell in love with it. It took a Sponsor that kept the meeting lively when only one teen would show up. The teens that stay are the ones that put themselves-full into the program. The members in the meeting became a community to text when something was going on. Created friendships in the group knowing they are safe. Additional things that kept them coming back in the beginning taking everything slow, having snacks & bringing dogs to the meetings.
 - Planting the seed of Al-Anon/Alateen service
- Service Manual Deanna M. Secretary (See Attachment Service Manual Workshop)
 - o For this Workshop we will use the 2018-2021 Al-Anon/Alateen Service Manual (P24-27).
 - On the inside front cover of the manual it reads: "Every Al-Anon and Alateen member is encouraged to
 actively use and study this Manual. It gives a clear and concise picture of the Al-Anon fellowship, its
 purpose and functions and how it helps us to resolve group problems and maintain unity."
 - On the next page under Preface it reads: "Questions pertaining to the Twelve Traditions and the Twelve
 Concepts of Service continually arise within our fellowship. Over the years, four booklets were

- introduced to assist members in resolving specific situations. In 1992, the four booklets were combined into one and retitled Al-Anon/Alateen Service Manual (P-24/27). This Manual reflects the collective experience of our membership in its ongoing effort to interpret the Traditions and Concepts of Service in a spirit of unity and harmony. Members seeking answers to specific questions of special situations may well find guidance within these pages. Each section has its own purpose, author and Table of Contents. The Index lists the many topics addressed throughout the Manual."
- As for the Manual. Did you know you can literally chair a meeting directly from the manual? The first section "Al-Anon & Alateen Groups at Work" gives the suggested meeting readings. Many groups read straight from the manual and many have made a group conscience to read a script. Just remember if for some reason you don't have access to your normal script, you can always default to the manual starting on page 11. The "Al-Anon and Alateen Groups at Work" explains how to start a group, help it grow, and discover how other members have solved problems common to groups. The harmony and success of each group depends on shared responsibility, a warm spirit of fellowship, and individual self-improvement."
- o Additional information members found interesting
 - Pg. 100 is an excellent source when talking about finances and our spiritual principles;
 Anonymity, Gratitude, Responsibility, Trust & Unity
 - Pg. $112 2^{nd}$ paragraph discusses limiting outside sources to a brief sentence or two. So we don't have to ban all outside information just don't make it the focal point of our sharings.
 - Pg. 92 & 130 Retreats are not a part of Al-Anon

Ask-It-Basket Questions:

- Will the Al-Anon "General Public" be invited to attend the Trustee presentation? If not should we have a "workshop" on Sunday afternoon?
 - Trustee's personal story will be on Saturday at Lunch. Anyone is welcome at that lunch or to join the assembly as a visitor.
- Currently Oregon Area does not have a Committee geared towards Young in Al-Anon Recovery. I came into the program when I was 26, I'm 40 now. AA has YPAA (Young Person in AA) where those who identify as young create programming that speaks to the young person in today's generation. Southern CA Al-Anon is sponsoring

YHA Aug. 3rd Young at Heart in Al-Anon similar to YPAA these committee's help with the transition from Alateen to Al-Anon. I would like to have discussion that Oregon develop an Area Committee of Young in Al-Anon Recovery to help others who are young and struggling with the effects of another's problem drinking. I have a flyer drafted that describes the framework. I attended the SSM and they were mostly older Al-Anons with a few young people. I've been active on the YHA committee since last July when meeting them at the Al-Anon international. These Young in Al-Anon service committees I feel will help with the transition and attract Young People to keep coming back and get involved at the Area or District Service.

- Contact the local District Representative to discuss this at the District meeting and then bring to AWSC through the links of Service.
- Will Katie's Delegate Presentation be electronically available to GR's?
 - Yes
- What is an "Acting GR"? How many Alternate GR's can a group have?
 - O Don't know what acting is. What is your Group or District Policy? There should only be one vote per group. Service Manual Page 137 discusses Alternate and Page 61-67 Encourages election of an alternate. If the GR or Alt are unable to go to the group they could ask a member to stand in with a group vote. Where is the commitment of the GR/Alt. You don't just send anyone when you know there is a vote.
- Is an alternate DR a member of AWSC?
 - No they are not Service Manual Page 171 Al-Anon Information Service Liaisons, District Representatives, Area Coordinators, Delegate, Assembly Officers, & a Chairman
